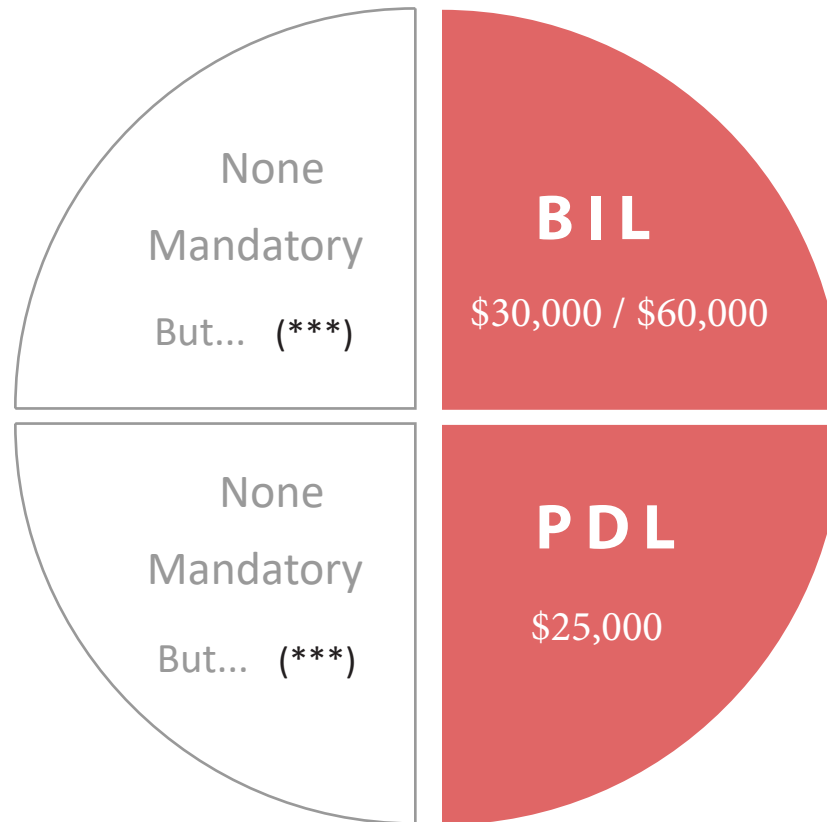




Texas State (At-Fault) Minimum Required Auto Insurance



BIL or Bodily Injury Liability - Covers expenses related to the injury or death of another driver or a pedestrian when an accident is your fault.

PDL or Property Damage Liability - Covers expenses related to the damage of another person's property—like vehicles, homes, buildings and other structures —when an accident is your fault.

(*)** - The State requires insurers to offer (**PIP**) or Personal Injury Protection with below limits, but you may reject in writing.

PIP - \$2,500

(*)** - The State requires insurers to offer (UM/UIM) Uninsured/Underinsured motorist coverage with below limits, but you may reject in writing.

UM/UIM BI (Bodily Injury) - \$30,000 / \$60,000

UM/UIM PD (Property Damage) - \$25,000
